In terms of provisions of the Rules, Bye-Laws, Regulations and SEBI Master Circular no. SEBI/HO/MRD/DP/CIR/P/2016/135 dated December 16, 2016, SEBI circular no. CIR/MRD/DoP-1/P/00108/2018 dated July 5, 2018 and SEBI/HO/MRD2/MRD2\_DCAP/P/CIR/2022/90 dated June 28, 2022; members of the Exchange are hereby informed that the Board of Directors of GAIL (INDIA) LIMITED (GAIL) have declared Interim Dividend of Rs.6.50/- per equity share of face value of Rs. 10/- each. The adjustment of the derivatives contracts in GAIL (INDIA) LIMITED (GAIL) will be w.e.f. February 07, 2025, being the ex-date.

**Adjustments for Futures Contracts:**

Base price of the Futures contracts on February 07, 2025, will be reference rate less aggregate amount of dividend of Rs.6.50/-. The reference rate to be reckoned for this purpose shall be the daily mark to market settlement price of the relevant futures contract.

**Adjustments for Options Contracts:**

The full value of Interim dividend of Rs.6.50/- would be deducted from all the cum-dividend strike prices on the ex-dividend date.

The revised options strike/futures base prices on account of adjustment would appear in decimal places and shall be rounded off to the nearest tick size.
